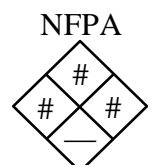

### Section 6 - Accidental Release Measures

**Spill /Leak Procedures:** Ventilate area of leak or spill. Remove all sources of ignition. Wear appropriate personal protective equipment. Isolate hazard area. Contain and recover liquid when possible. Use non-sparking tools and equipment. Collect liquid in an appropriate container or absorb with inert material and place in chemical water container. Do not use combustible materials such as sawdust. Do not flush to sewer

**Containment/Cleanup:** For large spills, dike far ahead of liquid spill for later disposal. Do not release into sewers or waterways.

### Section 8 - Exposure Controls / Personal Protection

**Engineering Controls:**

**Ventilation:** Provide general or local exhaust ventilation systems to maintain airborne concentrations below OSHA PELs (Sec. 2). Local exhaust ventilation is preferred because it prevents contaminant dispersion into the work area by controlling it at its source.

**Administrative Controls:**

**Respiratory Protection:** Seek professional advice prior to respirator selection and use. **Protective Clothing/Equipment:** Wear chemically protective gloves, boots, aprons, and gauntlets to prevent prolonged or repeated skin contact. Wear protective eyeglasses or chemical safety goggles, per OSHA eye- and face-protection regulations (29 CFR 1910.133). Contact lenses are not eye protective devices. Appropriate eye protection must be worn instead of, or in conjunction with contact lenses.

**Safety Stations:** Make emergency eyewash stations, safety/quick-drench showers, and washing facilities available in work area.
